Trainee Right to Appeal

A reminder to all assessors that a trainee can formally appeal an assessment decision. In summary:



The appeal can only be made by the learner affected by the decision and has to be communicated to the ITO in writing no later than 30 days of the assessment taking place.

- The subsequent appeal process is a formal review system managed by the Quality team.
- The overall outcome of the appeal will be notified to the Learner and Assessor within 15 working days of receipt.

Peer Review – Spotlight on NZQA Unit 11097

Do you assess 11097 - Listen actively to gain information in an interactive situation?

A first-time pass through peer review is rare for this standard. Here is some advice from our Peer Reviewer:

- Active listening techniques there needs to be evidence of attending, AND reflective listening, AND responding to non-verbal cues for both interactions.
- Paraphrasing a common problem is an answer that states "repeated back the instructions about.....". Paraphrasing is not repeating back, it is relaying information using your own words. Learner answers need to indicate the information they were given, and what they said to paraphrase it.
- Summary of information received the main pitfalls here are:

 a) the learner summarises the interaction rather than the information received
 b) the trainee summary is too brief (needs plenty of detail).
- **Responses** here the evidence needs to detail what the learner was responding to, how did they respond, and how was this appropriate for the person/ workplace/ culture.
- Administration some assessments come through with verification and assessor sections incomplete, these ones will not pass peer review, even if the trainee evidence meets.





Check the learner has the latest version of the assessment resource (2.2). This has questions that help to get the required evidence.

Read the learners answers and make sure their answer specifically answers the question.

Double check the verification pages have been completed, with comments, before sending for peer review.

Complete the assessor sections with comments (front page, and final page).
